1. The quotation (with HSN code) will be opened on the due date at 5:00 PM or on the next working day by the Tender Committee, in the presence of the bidders. Interested bidders may be present at the time of tender opening.
2. The Director ICMR-NIPCR reserves the right to accept the offer by individual items and reject any or all tenders without assigning any reason thereof and does not bind itself to accept lowest quotations.
3. Participation in this tender is by invitation only and is limited to the selected procuring entity's registered suppliers. Unsolicited offers are liable to be ignored. However, suppliers who desire to participate in such tenders in future may bring it to the notice of procuring entity and apply for registration as per procedure.
4. The prices quoted should be firm till the supplies are completed. Please quote the rates in words and figures. Rates quoted should be **free delivery** at destination including all charges otherwise the quotation is likely to be rejected.
5. Payment of sales tax is primarily the responsibility of the seller and will not be paid unless the percentage value is clearly mentioned in the quotations. If no indication regarding GST is recorded in the quotation, the GST will be considered as included.
6. If the deliveries are not maintained and due to that account Procuring Entity is forced to buy the material at your risk and cost from elsewhere, the loss or damage that may be sustained there by will be recovered from the defaulting supplier.
